NOTICE OF APPLICABILITY: STATE WATER RESOURCES CONTROL BOARD CLEAN WATER ACT SECTION 401 GENERAL WATER QUALITY CERTIFICATION, SB18054IN, FOR REGIONAL GENERAL PERMIT 8 FOR M&T RANCH, PARROTT-PHELAN DAM AND DIVERSION STRUCTURE EMERGENCY REPAIR PROJECT, BUTTE COUNTY, WDID NO. 5A04CR00321

This letter serves to notify M&T Ranch the Parrott-Phelan Dam and Diversion Structure Emergency Repair Project conducted under the Army Corps of Engineers Regional General Permit 8 (RGP 8) for repair related activities on Butte Creek (WDID No. 5A04CR00321) is certified under State Water Resources Control Board Clean Water Act (CWA) Section 401 General Water Quality Certification SB18054IN.

EMERGENCY WORK DESCRIPTION

The Project consists of placing approximately 20 cubic yards of rock in the hole between the face of the weir and the upstream wingwall of the fish ladder to repair erosion that that has taken place. The Project will prevent further erosion and destabilization of the dam structure. Additionally, the fyke pipe outfall, located downstream of the weir, will be exposed to maintain function of the pipe during the upcoming winter season.
