### ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER; COUNTY OF GLENN, COUNTY ROAD 67 BRIDGE REPLACEMENT 11C-17 PROJECT (WDID NO. 5A11CR00038A1), GLENN COUNTY

This Order responds to the 9 February 2024 request for an amendment to the County of Glenn, County Road 67 Bridge Replacement 11C-17 Project Section 401 Water Quality Certification (WDID No. 5A11CR00038).
