# ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; CAPITAL EQUITY MANAGEMENT GROUP, GRANITE LAKES ESTATE PROJECT (WDID# 5A31CR00291A2), PLACER COUNTY

This Order responds to the 12 November 2021 request for an amendment of the Granite Lakes Estates Project (Project) Section 401 Water Quality Certification (WDID#5A31CR00291). The project was originally certified in May 2004 (WDID#5A31CR00079). Construction commenced but abruptly halted mid project due to economic issues. A new Certification under a new WDID number was issued on 22 June 2010 (WDID#5A31CR00291) and amended on 18 January 2019 (WDID#5A31CR00291A1).

The requested second amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

### AMENDMENT:

Capital Equity Management Group is requesting a time extension through 14 March 2026 to coincide with expiration of the United States Army Corps of Engineers 2021 Nationwide Permits. A time extension was authorized by the United States Army Corps of Engineers on 22 April 2022.

Capital Equity Management Group has provided documentation from the United States Army Corps of Engineers (SPK-2000-00681) authorizing in-water construction activities to continue until 14 March 2026.

No fee was required for this amendment. Total fees of \$1,238.00 for the original Certification have been received.
