**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY  
CONDITIONED WATER QUALITY CERTIFICATION; WESTERN CARE  
CONSTRUCTION COMPANY INC, TIMBERLINE PROJECT  
(WDID#5A31CR00309A3), PLACER COUNTY**

This Order responds to the 27 March 2025 request for an amendment of the Timberline Project (Project) Section 401 Water Quality Certification (WDID#5A31CR00309). The original Water Quality Certification (Certification) was issued on 30 August 2013. The Certification was amended on 25 October 2023 and 6 February 2025. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

**AMENDMENT:**

Western Care Construction Company Inc. is requesting a time extension through 29 April 2030. A time extension was authorized by the United States Army Corps of Engineers on 1 April 2025. Western Care Construction Company Inc. has provided documentation from the United States Army Corps of Engineers (SPK-1993-00448) authorizing in-water construction activities to continue until 29 April 2030.

The Certification is amended to reflect an updated expiration date of 29 April 2030.

**APPLICATION FEE RECEIVED:**

No fee was required for this amendment. Total fees of \$35,143.00 for the original Certification were received on 23 March 2011. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
