ORDER AMENDING NOTICE OF APPLICABILITY FOR COVERAGE UNDER GENERAL ORDER NO. R5- 2020-0048, WASTE DISCHARGE REQUIREMENTS AND CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION OF THE WESTERN PLACER COUNTY HABITAT CONSERVATION PLAN PROGRAMMATIC GENERAL PERMIT; CITY OF LINCOLN, MCBEAN PARK DRIVE BRIDGE REPLACEMENT PROJECT (WDID#5A31CR00534- 015A1), PLACER COUNTY

This Order responds to the 11 March 2024 request for an amendment of the McBean Park Drive Bridge Replacement Project (Project) Notice of Applicability (WDID#5A31CR00534-015).
