**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY
CONDITIONED WATER QUALITY CERTIFICATION; SVLC 23, LLC, SVLC 23
PROPERTY/SIERRA VIEW WESTPARK PROJECT (WDID#5A31CR00569A1),
PLACER COUNTY**

This Order responds to the 21 July 2023 request for an amendment of the SVLC 23 Property/Sierra View Westpark (Project) Section 401 Water Quality Certification (WDID#5A31CR00569). The original Water Quality Certification (Certification) was issued on 21 March 2022. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

SVLC 23, LLC is requesting the transfer of the legally responsible party for the Project and a time extension for in-water activity authorization. The legally responsible party change will allow Ryan Biziewski to proceed with the Project described in the original Certification. SVLC 23, LLC has provided documentation from the United States Army Corps of Engineers (SPK-2017-00861) authorizing in-water construction activities to continue until 20 March 2027. The Certification is amended to change John Welch to Ryan Biziewski and extend the expiration date to 20 March 2027.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$22,837.00 for the original Certification were received on 22 December 2021. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
