ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; TAYLOR MORRISON OF CALIFORNIA, LLC, WILDHAWK NORTH PROJECT (WDID#5A34CR00314A2), SACRAMENTO COUNTY

This Order responds to the 5 April 2021 request for a second amendment of the Wildhawk North Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00314). The original Water Quality Certification (Certification) was issued on 28 November 2006 and amended on 2 June 2014 (WDID#5A34CR00314A1). The requested amendment is hereby approved.
