**ORDER AMENDING NOTICE OF APPLICABILITY FOR COVERAGE UNDER
GENERAL ORDER NO. R5- 2019-0023, WASTE DISCHARGE REQUIREMENTS
AND CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION OF
THE SOUTH SACRAMENTO HABITAT CONSERVATION PLAN PROGRAMMATIC
GENERAL PERMIT, HARVEST WATER PIPELINE SYSTEM PROJECT
(WDID#5A34CR00759-014A1), SACRAMENTO COUNTY**

This Order responds to the 16 November 2021 request for an amendment of the Harvest Water Pipeline System Project (Project) Notice of Applicability For Coverage Under General Order No. R5-2019-0023 (WDID#5A34CR00759-014). The original Notice of Applicability (NOA) was issued on 12 November 2021. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Sacramento Regional County Sanitation District is requesting an administrative correction to the dates of construction authorized in the original NOA. The original dates authorized for construction activities were 1 January through 31 May. The dates for construction are amended to update authorization to 1 January 2023 through 30 November 2026.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Amendment fees of \$2,066.00 and Project Impact Fees of \$46,916.00 for the original Certification were received on 25 August 2021 and 8 October 2021, respectively. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
