# ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; K. HOVNANIAN AT JAEGER RANCH, LLC, THE RANCH PROJECT (WDID#5A34CR00797A4), SACRAMENTO COUNTY

This Order responds to the 21 April 2025 request for an amendment of the Ranch Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00797). The original Water Quality Certification (Certification) was issued on 22 July 2020. The Certification was amended on 6 August 2020 (WDID#5A34CR00797A1), 9 November 2022 (WDID#5A34CR00797A2), and 7 March 2025 (WDID#5A34CR00797A3). The requested fourth amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

#### AMENDMENT:

K. Hovnanian at Jaeger Ranch, LLC is requesting a change in permanent impacts for Vernal Pool Aquatic resource from 6.107 acres to 5.085 acres.

Figure 1 – Project Location Map




Figure 2 – Site Impacts Map
