ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; MERITAGE HOMES, PANHANDLE 105 PROJECT (WDID#5A34CR00845A1), SACRAMENTO COUNTY

This Order responds to the 6 March 2023 request for an amendment of the Panhandle 105 Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00845). The original Water Quality Certification (Certification) was issued on 19 August 2022. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Meritage Homes is requesting a change to the required mitigation methods from purchasing National Fish and Wildlife Foundation (NFWF) In-Lieu Fee Program credits to purchasing mitigation bank credits from Elsie Gridley Mitigation Bank. The change was authorized by the United States Army Corps of Engineers on 2 March 2023.

The Certification is amended as shown below:

VII.K.3 Total Required Compensatory Mitigation

a. The Permittee is required to provide compensatory mitigation for the authorized impact to 1.3 acre of wetland by purchasing 1.3 vernal pool mitigation credits from the Elsie Gridley Mitigation Bank
