ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; CITY OF ELK GROVE SOUTHEAST INDUSTRIAL AREA STORM DRAIN PROJECT (WDID#5A34CR00846A1), SACRAMENTO COUNTY

This Order responds to the 11 August 2022 request for an amendment of the Southeast Industrial Storm Drain Project (Project) Section 401 Water Quality Certification (WDID#5 A34CR00846). The original Water Quality Certification (Certification) was issued on 14 June 2022. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

The City of Elk Grove is requesting an amendment for change in Project impacts to waters of the state and change in the compensatory mitigation requirements.

The Certification is amended as shown below:

Description of Direct Impacts to Waters of the State

Temporary impacts will result from the excavation of the pond area to accommodate the stormwater facilities. Permanent impacts to wetland habitat will result from the installation of the new storm drain outfall and placement of rock slope protection.

Permanent impacts are categorized as those resulting in a physical loss in area and also those degrading ecological condition.

X. Compensatory Mitigation

No compensatory mitigation was required for permanent impacts because the Project will not result in a net loss of wetland habitat. Approximately 1.72 acres of excavation within the wetland to accommodate stormwater facilities will remove dense vegetative cover from the pond and provide a mix of open-water aquatic habitat for special status species such as giant gartersnake and western pond turtle.




Figure 2: Updated Project Impacts Map
