ORDER AMENDING NOTICE OF APPLICABILITY: STATE WATER RESOURCES CONTROL BOARD AMENDED ORDER FOR CLEAN WATER SECTION 401 GENERAL WATER QUALITY CERTIFICATION FOR SMALL HABITAT RESTORATION PROJECTS FILE NO. SB12006GN FOR RECLAMATION DISTRICT NO. 108, MARKET STREET GRAVEL INJECTION AND RIFFLE PROJECT, SHASTA COUNTY, WDID NO. 5A45CR00628A1

This Order responds to the 22 January 2023 request for an amendment of the Market Street Gravel Injection and Riffle Project Notice of Applicability (WDID No. 5A45CR00628). The original Notice of Applicability was issued on 20 December 2022. The requested amendment is hereby approved, and the original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Reclamation District No. 108 is requesting an amendment to the Notice of Applicability to change the project description for the temporary berm to the updated design that was permitted by United States Army Corps of Engineers. Therefore, Section II.B has been amended in underline format below. In addition, Attachment A, Figure 2 has been amended.

II. Project Description

B. Temporary Berm

A temporary berm of spawning gravel will be placed <u>along the northern</u> <u>boundary of</u> the project area to slow water velocity and to manage any turbidity resulting from the work; <u>the berm will end in the river</u>, <u>leaving the downstream</u> <u>end open</u>, <u>rather than returning to shore</u>, <u>and will not encompass the cobble spoil area</u>. The berm will be repurposed as spawning gravel augmentation at this site.
