NOTICE OF APPLICABILITY FOR COVERAGE UNDER ORDER NO. 2004-0004-DWQ, STATEWIDE GENERAL WASTE DISCHARGE REQUIREMENTS FOR DREDGED OR FILL DISCHARGES TO WATERS DEEMED BY THE U.S. ARMY CORPS OF ENGINEERS TO BE OUTSIDE OF FEDERAL JURISDICTION, SANDY BEACH COUNTY PARK PHASE 2 ACCESS IMPROVEMENTS PROJECT (WDID#5A48CR00210), SOLANO COUNTY

On 7 May 2025, Solano County submitted a Notice of Intent (NOI) to enroll under and comply with State Water Resources Control Board (State Water Board) Order No. 2004-0004-DWQ, Statewide General Waste Discharge Requirements for Dredged or Fill Discharges to Waters Deemed by the United States. Army Corps of Engineers to be Outside of Federal Jurisdiction.

The Central Valley Water Quality Control Board (Central Valley Water Board) has reviewed your enrollment materials and finds the Sandy Beach County Park Phase 2 Access Improvements Project (Project) meets the requirements of, and is hereby enrolled under, Order No. 2004-0004-DWQ. You may proceed with your Project in accordance with the Order.

Please familiarize yourself with the requirements of Order No. 2004-0004-DWQ. You are responsible for complying with all applicable Order requirements. Failure to comply with Order No. 2004-0004-DWQ constitutes a violation of the California Water Code and may result in enforcement action or termination of enrollment under the Order.

#### PROJECT DESCRIPTION:

The 0.79-acre Project consists of extending an existing concrete ADA walkway with handrails down to the beach, constructing an additional boat and trailer parking stall at

the southern edge of the existing parking lot, and pouring a new concrete pedestrian walkway with handrails from the existing parking lot down to the boat ramp and dock at the river's edge.

Project elements that affect aquatic resources include constructing the new walkway down to the boat ramp and extension of the existing concrete ADA walkway with handrails down to the beach. Impacts will occur on the western bank of the Sacramento River between the top of bank and the high tide line. The Project will temporarily impact 0.03 acre/100 linear feet and permanently impact 0.04 acre/90 linear feet of riparian habitat zone. Temporarily impacted areas will be restored to pre-Project condition.

## PROJECT LOCATION:

The Project is located at 2333 Beach Drive, Rio Vista, CA 94571. The approximate center of the Project area is located at latitude 38.139359°N and longitude 121.695253°W.

#### PROJECT SCHEDULE:

The Project is expected to begin construction on 1 June 2026 and finish construction 1 June 2031.

#### APPLICATION FEE RECEIVED:

\$4,212.00 was received on 15 May 2025.

The fee amount was determined as required by California Code of Regulations, title 23, sections 3833(b)(3) and 2200(a)(3) and was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.

#### **MITIGATION AND MINIMIZATION MEASURES:**

You must implement the minimization measures proposed in your Notice of Intent.

#### **TERMINATION OF COVERAGE:**

Upon completion of the Project, you shall submit a complete Notice of Termination (NOT) requesting to be un-enrolled under Order No. 2004-0004-DWQ. Attachment 2 to the Order contains the NOT form.
