ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; MOUNTAIN HOUSE DEVELOPERS, LLC, NEIGHBORHOOD I- DRY CREEK ROAD CROSSINGS PROJECT (WDID#5B39CR00416A1), SAN JOAQUIN COUNTY

This Order responds to the 19 March 2025 request for an amendment of the Neighborhood I- Dry Creek Road Crossings Project (Project) Section 401 Water Quality Certification (WDID#5B39CR00416). The original Water Quality Certification (Certification) was issued on 17 January 2025. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Mountain House Developers, LLC is requesting an amendment to change the source of compensatory mitigation for Project impacts. Mitigation credits will be obtained from Zacharias Ranch Mitigation Bank in place of the National Fish and Wildlife Foundation In-Lieu Fee Program.

The Certification is amended as shown below:

XIII.K. Compensatory Mitigation for Permanent Impacts:

5. Total Required Compensatory Mitigation

a. The Permittee is required to provide compensatory mitigation for the authorized impact to 0.13 acre of stream channel habitat by purchasing 0.13 resource mitigation bank Credits from Zacharias Ranch Mitigation Bank.

The Certification is amended to redact Attachment B, "In-Lieu Fee Compensatory Mitigation Information," "Table 4: In-Lieu Fee Program" and "Table 5: Mitigation Type Information." The replacement section is included below.
