**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY
CONDITIONED WATER QUALITY CERTIFICATION; COUNTY OF TUOLUMNE, LIME
KILN ROAD CROSSING CURTIS CREEK BRIDGE REPLACEMENT PROJECT
(WDID#5B55CR00128A1), TUOLUMNE COUNTY**

This Order responds to the 25 March 2025 request for an amendment of the Lime Kiln Road Crossing Curtis Creek Bridge Replacement Project (Project) Section 401 Water Quality Certification (WDID#5B55CR00128). The original Water Quality Certification (Certification) was issued on 14 February 2020. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Tuolumne County is requesting a time extension through 14 March 2026. A time extension was authorized by the United States Army Corps of Engineers on 2 December 2022. Tuolumne County has provided documentation from the United States Army Corps of Engineers (SPK-2018-00933) authorizing in-water construction activities to continue until 14 March 2026.

The Certification is amended to update the expiration date to 14 March 2026.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$3,184.00 for the original Certification were received on 7 November 2018. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
