ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; CITY OF FARMERSVILLE, DEEP CREEK RESTORATION PROJECT (WDID#5C54CR00097), TULARE COUNTY

This Order amends the Section 401 Water Quality Certification (WDID#5C54CR00097) for the Deep Creek Restoration Project (Project) to correct the fees received. The original Water Quality Certification (Certification) was issued on 19 August 2019. The original Certification is therefore amended as described below.

AMENDMENT:

An application fee of \$400 was received on 16 August 2018. The fee amount was determined as required by California Code of Regulations, Title 23, sections 3833(b)(3) and 2200(a)(3), and was calculated as category D – Ecological Restoration and Enhancement Projects (fee code 85) with the dredge and fill fee calculator.
