**NOTICE OF TERMINATION OF COVERAGE UNDER WASTE DISCHARGE REQUIREMENTS ORDER NO. R5-2008-0149-045, CALIFORNIA ARMY NATIONAL GUARD (CAARNG) STOCKTON FACILITY, FIELD MAINTENANCE SHOP #24 (FMS) AND ARMY AVIATION SUPPORT FACILITY (AASF), 8010 SOUTH AIRPORT WAY, STOCKTON, SAN JOAQUIN COUNTY, CALIFORNIA**

On 12 September 2013, the Executive Officer of the Central Valley Regional Water Quality Control Board (Central Valley Water Board) issued Notice of Applicability No. R5-2008-0149-045 (NOA) granting the California Army National Guard (CAARNG) Stockton Facility Field Maintenance Shop #24 (FMS) and Army Aviation Support Facility (AASF) coverage under the *Waste Discharge Requirements for In-Situ Groundwater Remediation at Sites with Volatile Organic Compounds, Nitrogen Compounds, Perchlorate, Pesticides, Semi-Volatile Compounds, Hexavalent Chromium and/or Petroleum Hydrocarbons*, Order No. R5-2008-0149 (Order), for in-situ groundwater remediation using In-Situ Chemical Oxidation (ISCO) to target petroleum hydrocarbons in soil and groundwater at both the CAARNG Stockton Facilities, FMS and AASF.

The FMS completed several rounds of ISCO injections on 15 December 2016, quarterly monitoring ceased after the third quarter of 2016, and semi-annual monitoring ceased after first quarter 2022. The results and post-injection monitoring results were presented in the *Remedial Action Completion Report (RACR) for In-Situ Chemical Oxidation (ISCO)* (ECM, 2015) and the *Remedial Action Completion Report (RACR) for In-Situ Chemical Oxidation (ISCO) and Vapor Energy Generation (VEG)* (ECM, 2018). The site is currently conducting annual groundwater and soil gas monitoring.

The AASF completed ISCO injections on 1 October 2013 and 6-month-post-injection monitoring on 4 April 2014. On 16 March 2015, Central Valley Water Board staff concurred with No Further Action and closure of the petroleum hydrocarbon investigations at the site.

Coverage under the Order is no longer required. Based on this information, the Central Valley Water Board concurs and hereby terminates the CAARNG Stockton Facility NOA
