NOTICE OF TERMINATION; GENERAL WASTE DISCHARGE REQUIREMENTS ORDER R5-2022-0006 FOR LIMITED THREAT DISCHARGES TO SURFACE WATER, US ARMY CORPS OF ENGINEERS AND FLATIRON DRAGADOS SUKUT JOINT VENTURE, LAKE ISABELLA DAM SAFETY MODIFICATION PROJECT, KERN COUNTY

Thank you for submitting the Request for Termination Form dated 23 March 2023 requesting termination of coverage under the Limited Threat General Order R5-2022-0006 for the Lake Isabella Dam Safety Modification Project (Project). According to the Request for Termination Form and Self-Monitoring Reports, there has not been a discharge from the Project since 31 March 2021.

On 30 May 2019, the Central Valley Regional Water Quality Control Board issued a Notice of Applicability for the Project, which was assigned Limited Threat General Order R5-2016-0076-053 and Waste Discharge Identification 5C15NP00019. Notice of Applicability R5-2016-0076-053 was amended on 15 December 2020, and Limited Threat General Order R5-2022-0006 was adopted on 17 February 2022 to replace Limited Threat General Order R5-2016-0076. Except for purposes of enforcement, coverage is hereby terminated as of 23 March 2023 through this letter.

Please note that you must still submit your last quarterly monitoring report required under the Limited Threat General Order to the Compliance/Enforcement staff. Failure to do so subjects you to mandatory minimum penalties or discretionary penalties.

Lastly, our records show that the Discharger has not paid the invoice issued on 8 December 2022 (Invoice No. WD-0215516) for the subject site. The Discharger is advised to pay this invoice immediately to avoid potential penalties.
