ORDER R5-2014-0114

**RESCINDING NPDES PERMITS AND WASTE DISCHARGE REQUIREMENTS**

a) **CALIFORNIA DEPARTMENT OF PARKS AND RECREATION, COLONEL ALLENSWORTH STATE HISTORIC PARK WASTEWATER TREATMENT FACILITY, TULARE COUNTY**

Waste Discharge Requirements Order 95-119, adopted on 26 May 1995, prescribes requirements for the discharge from the Colonel Allensworth State Historic Park's wastewater treatment facility in Tulare County. The California Department of Parks and Recreation applied for coverage under Water Quality Order 97-10-DWQ, and a Notice of Applicability was issued on 12 May 2014. Therefore, WDRs Order 95-119 is no longer necessary and should be rescinded. (LR)

b) **MADERA COUNTY MAINTENANCE DISTRICT NO. 6, LAKESHORE PARK, WASTEWATER TREATMENT FACILITY, MADERA COUNTY**

Waste Discharge Requirements Order 85-158, adopted on 28 June 1985, prescribes requirements for the discharge from the Lakeshore Park Wastewater Treatment Facility at Bass Lake. Madera County Maintenance District No. 6 applied for coverage under Water Quality Order 97-10-DWQ, and a Notice of Applicability was issued on 27 May 2014. Therefore, WDRs Order 85-158 is no longer necessary and should be rescinded. (LR)

c) **MADERA COUNTY MAINTENANCE DISTRICT NO. 24, TEAFORD MEADOWS WASTEWATER TREATMENT FACILITY, MADERA COUNTY**

Waste Discharge Requirements Order 85-110, adopted on 31 May 1985, prescribes requirements for the discharge from the Teaford Meadows' Wastewater Treatment Facility at Bass Lake. Madera County Maintenance District No. 24 applied for coverage under Water Quality Order 97-10-DWQ, and a Notice of Applicability was issued on 15 May 2014. Therefore, WDRs Order 85-110 is no longer necessary and should be rescinded. (LR)


d) **MADERA COUNTY MAINTENANCE DISTRICT NO. 28, RIPPERDAN WASTEWATER TREATMENT FACILITY, MADERA COUNTY**

Waste Discharge Requirements Order 90-261, adopted on 28 September 1990, prescribes requirements for the discharge from the Ripperdan Wastewater Treatment Facility in south Madera County. Madera County Maintenance District No. 28 applied for coverage under Water Quality Order 97-10-DWQ, and a Notice of Applicability was issued on 27 May 2014. Therefore, WDRs Order 90-261 is no longer necessary and should be rescinded. (LR)

- e) **TEICHERT AGGREGATES, TRACY ROCK PLANT, SAN JOAQUIN COUNTY**  
Waste Discharge Requirements Order R5-2002-0220, adopted on 6 December 2002, prescribes requirements for the discharge of aggregate washwater at Teichert Aggregates' Tracy Rock Plant in San Joaquin County. Washwater generated from aggregate washing activities was historically recycled or discharged along with storm water into a series of on-site settling ponds. In a letter dated 5 March 2014, Teichert Aggregates notified the Regional Board stating that the facility was permanently closed in 2008 and there will be no further discharge. Because the facility is no longer in operation, it is appropriate to rescind WDRs Order R5 2002-0220
- f) **TRI-ENTERPRISES, INC., LAKERIDGE CAMPING AND BOATING RESORT, ONSITE WASTEWATER TREATMENT SYSTEM, FRESNO COUNTY**  
Waste Discharge Requirements Order 66-130, adopted on 28 April 1966, prescribes requirements for the discharge from the Lakeridge Camping and Boating Resort near Pine Flat Lake. Tri-Enterprises, Inc., applied for coverage under Water Quality Order 97-10-DWQ, and a Notice of Applicability was issued on 28 May 2014. Therefore, WDRs Order 66-130 is no longer necessary and should be rescinded. (LR)

IT IS HEREBY ORDERED that the above NPDES Permit and Waste Discharge Requirement orders are rescinded.
