ORDER R5-2016-0059

**RESCINDING WASTE DISCHARGE REQUIREMENTS/NPDES PERMITS**

The California Regional Water Quality Control Board, Central Valley Region, finds that the following Board adopted Orders and Resolutions are no longer applicable for the reasons shown:

- a. **Master Reclamation Permit (MRP) Order R5-2004-0132**, adopted on 10 September 2004, prescribes requirements for City of Brentwood's water recycling program; the reclamation of tertiary treated effluent from the City of Brentwood wastewater treatment plant WWTP. On 29 March 2016, the City's water recycling program was enrolled under Water Quality Order WQ 2014-0090-DWQ, *General Waste Discharge Requirements for Recycled Water Use*. Therefore, it is appropriate to rescind MRP Order R5-2004-0132.
- b. **Discharge Requirements Order No. 94-268**, adopted on 16 September 1994, prescribes requirements for the discharge from Clear Creek Mobile Estates, Shasta County (Facility). The Facility is comprised of a wastewater collection system with three parallel septic tanks, a common sump, a wet well/pump station, a dosing tank, sand filter, and leach field system. The Facility is now regulated under Water Quality Order 2014-0153-DWQ (General Order) for discharges to land from small domestic systems with a maximum average daily flow of 100,000 gallons or less. Therefore, it is appropriate to rescind Waste Discharge Requirements Order 94-268.
- c. **Waste Discharge Requirements Order 93-009**, adopted on 29 January 1993, prescribes requirements for the discharge from the Edward Hyatt Power Plant, Butte County (Facility). The Facility is comprised of a septic tank, two lift stations, two ponds, and leach field disposal system. The Facility is now regulated under Water Quality Order 2014-0153-DWQ (General Order) for discharges to land from small domestic systems with a maximum average daily flow of 100,000 gallons or less. Therefore, it is appropriate to rescind Waste Discharge Requirements Order 93-009.
- d. **Waste Discharge Requirements Order 86-208** were adopted on 24 October 1986. The WDRs prescribe requirements for Granite Construction Company for the discharge of wash water from aggregate and hot mix asphaltic concrete processing plants to a series of ponds. The facility included a concrete batch plant, concrete washout basin, and three sedimentation-percolation wash water ponds. An inspection conducted on 18 March 2016 confirmed that the facility was successfully decommissioned, as described in a Closure Report. Based on staff's review of the analytical data, no additional sampling is required because reported metals concentrations were statistically similar to

background conditions. Because the facility is no longer in operation and all previous facilities have been removed, it is appropriate to rescind WDRs Order 86-208

- e. **Waste Discharge Requirements Order 89-049**, adopted on 31 March 1989, and prescribes requirements for the wastewater discharges from IVE West Coast Trust, Honey Rock Camp (Facility) Butte County. The Facility is comprised of a wastewater collection system with a septic and two treatment ponds. The Facility (under its new name Our Lady of Peace Retreat Center) is now regulated under Water Quality Order 2014-0153-DWQ (General Order) for discharges to land from small domestic systems with a maximum average daily flow of 100,000 gallons or less. Therefore, it is appropriate to rescind Waste Discharge Requirements Order 89-049.
- f. **Waste Discharge Requirements Order 95-162**, adopted on 23 June 1995, prescribes requirements for the wastewater discharges from Indian Valley CSD, Taylorsville STP, Plumas County (Facility). The Facility is comprised of a wastewater collection system with septic tank, lift station, dosing tanks, and leachfields. The Facility is now regulated under Water Quality Order 2014-0153-DWQ (General Order) for discharges to land from small domestic systems with a maximum average daily flow of 100,000 gallons or less. Therefore, it is appropriate to rescind Waste Discharge Requirements Order 95-162.

IT IS HEREBY ORDERED that the above orders are rescinded.
