**NO FURTHER ACTION REQUIRED, UST CASE #450122, AND RESCISSION, CLEANUP AND ABATEMENT ORDER R5-2007-0707, FORMER CHACON'S AUTO CLINIC INC., 4657 SHASTA DAM BOULEVARD, CITY OF SHASTA LAKE, SHASTA COUNTY**

This letter confirms the completion of a site investigation for the underground storage tanks at the above-described location. Thank you for your cooperation throughout this investigation. Your willingness and promptness in responding to our inquiries concerning your underground storage tanks are greatly appreciated.

Based on the information in the above-referenced file and with the provision that the information provided to this agency was accurate and representative of site conditions, this agency finds that the site investigation and corrective action carried out at your underground storage tank site is in compliance with the requirements of subdivisions (a) and (b) of Section 25296.10 of the Health and Safety Code and with corrective action regulations adopted pursuant to Section 25299.3 of the Health and Safety Code and that no further action related to the petroleum release(s) at the site is required. Also, this letter serves as our notice of rescission of Cleanup and Abatement Order R5-2007-0707.

Please note that per Health and Safety Code Section 25299.57, Claims for reimbursement of corrective action cost submitted to the Underground Storage Tank Cleanup Fund more than 365 days after the date of this letter or issuance or activation of the Fund's Letter of Commitment, whichever occurs first, will not be reimbursed unless one of the following exceptions apply:

- a) Claims are submitted pursuant to Section 25299.57 subdivision (k) (reopened UST case); or
- b) Submission within the time frame was beyond the claimant's reasonable control, ongoing work is required for closure that will result in the submission of claims beyond that time period, or that under the circumstances of the case, it would be unreasonable or inequitable to impose the 365-day time period.
