## NOTICE OF APPLICABILITY

WAIVER OF REPORT OF WASTE DISCHARGE AND WASTE DISCHARGE REQUIREMENTS FOR SPECIFIC TYPES OF DISCHARGE WITHIN THE CENTRAL VALLEY REGION, SACRAMENTO SIKH SOCIETY AND ACE DESIGN & CONSTRUCTION, INC SACRAMENTO SIKH SOCIETY WATERLINE FLUSHING PROJECT SACRAMENTO COUNTY

On 23 December 2020, Ace Design & Construction, Inc. submitted on behalf of Sacramento Sikh Society information to verify compliance for coverage under the Waiver of Report of Waste Discharge and Waste Discharge Requirements for Specific Types of Discharges within the Central Valley Region, Order R5-2018-0085 (Waiver) for discharge of water from hydrostatic testing of newly installed water lines. The submittal contains all the information required to evaluate the applicability of the Waiver; therefore, the discharge qualifies for the category of hydrostatic testing and meets the conditions of the Waiver. The discharge is hereby covered under the Waiver, Order R5-2018-0085-0051. Please include this number on all correspondences related to this discharge.

### PROJECT LOCATION AND DESCRIPTION

The Sacramento Sikh Society Project is located at 7676 Bradshaw Road in Sacramento County. Ace Design & Construction, Inc. (contractor) requests authorization to discharge water generated from hydrostatic testing. Potable water that has been chlorinated will be used to flush newly installed water lines. The chlorinated water will be stored in a tank and dechlorinated (chlorine levels to negligible) prior to discharge on-site. The application area is approximately 5 acres of native grass. Application will be via sprinkler. Approximately 17,000 gallons of water is anticipated for intermittent discharges during the flushing activities. Discharges will take place on property owned by the Sacramento Sikh Society.

The Project is within the jurisdiction of the Central Valley Water Quality Control Board and the operative Water Quality Control Plan is the Sacramento and San Joaquin River Basin, Fifth Edition, revised May 2018 (hereafter Basin Plan). The Basin Plan designates beneficial uses, establishes water quality objectives, contains implementation plans and policies for protecting waters of the Basin, and incorporates by reference plans and policies adopted by the State Water Resources Control Board. Pursuant to §13263(a) of the California Water Code (CWC), waste discharge requirements must implement the Basin Plan.

#### FACILITY-SPECIFIC REQUIREMENTS

Please review the attached Waiver documents and ensure that the discharge complies with the Conditions of Discharge contained in Attachment A of the Waiver. Ace Design & Construction, Inc. and the Sacramento Sikh Society is responsible for compliance with the Waiver and must provide sufficient oversight to ensure compliance and prompt reporting of any non-compliance.
