NOTICE OF APPLICABILITY (NOA); CONDITIONAL WAIVER OF WASTE DISCHARGE REQUIREMENTS FOR SMALL FOOD PROCESSORS AND SMALL WINERIES WITHIN THE CENTRAL VALLEY REGION; ORDER NO. R5-2009-0097-0017; BARIANI OLIVE OIL, LLC; YOLO COUNTY

Central Valley Regional Water Quality Control Board (Central Valley Water Board) staff received your application including the Report of Waste Discharge (RWD) and application fee of \$1,226 submitted for Bariani Olive Oil, LLC for regulatory coverage under the *Conditional Waiver of Waste Discharge Requirements for Small Food Processors and Small Wineries within the Central Valley Region, Order No. R5-2009-0097* (Order). Based on the information in the application, we have determined that the Discharger meets the required conditions for approval under this Order for your facility and the proposed waste discharge. You are hereby assigned Order No. R5-2009-0097-0017.


The Order, adopted by the Central Valley Water Board on 8 October 2009, is a conditional waiver of waste discharge requirements for small wineries and small food processors. The Order is enclosed and may be viewed on our website at

You are urged to familiarize yourself with the contents of the entire Order which prescribes mandatory discharge and monitoring requirements. The facility must be operated in accordance with the requirements contained in the General Order, Standard Provisions and Reporting Requirements for Waste Discharge Requirements, and with the information submitted in the RWD.

DISCHARGE DESCRIPTION

Sebastian Bariani (referred to as Discharger) owns and operates Bariani Olive Oil, LLC located at 30400 County Road 16 Zamora in Yolo County (APN 54-230-10). The facility will crush approximately 1,500 tons of olives per year. The Discharger has estimated that approximately 32,000 gallons of process wastewater will be produced on an annual basis. Therefore, no more than 100,000 gallons of wastewater per year will be land applied. All activities producing wastewater will be conducted under the cover of a permanent roof structure and/or inside a covered building. Process wastewater is pumped into a 3,000 gallon polyethylene tank where it is mixed with the solid waste (olive paste) before being spread onto the field by a 2,700

gallon manure spreader. Volume of wastewater generated is estimated by the number of times the spreader is filled. Waste will be distributed as evenly as possible over the 132 acre olive orchard, with at least a seven day rest period between wastewater applications to any one area. The application area will be rotated with each application. Wastewater will not be applied during periods of precipitation, when soil is saturated, or when standing water is present in the application area.

The Discharger estimates that no more than 900 tons (wet weight) of solids will be produced annually based on the expected volume (1,500 tons) to be crushed each year. Solids are collected and mixed with the process wastewater and applied via a tractor pulled manure spreader. No storage of solids wastes occurs. The solid waste is spread as a soil amendment at the rate of approximately 2.5 tons/acre/year onto the 132 acres of farmland.

MONITORING AND REPORTING

This Order includes specific monitoring requirements that you must implement and reporting requirements you must comply with, including routine monitoring and reporting to the Central Valley Water Board. Please review the Monitoring and Reporting Program (MRP) closely and establish the appropriate record keeping system so that you are able to complete the required *Annual Monitoring Report* form, contained in the Order. The *Annual Monitoring Report* form must be submitted to our office by **1 February of each year**, even if there is no discharge during the reporting year.

GENERAL INFORMATION AND REQUIREMENTS

This Order includes specific and general conditions required for your operation. In addition, you must maintain control over the discharge and operate in accordance to the information provided in your application.

Please review this Notice of Applicability carefully to ensure that it completely and accurately reflects the facility name, location, and discharge. Failure to comply with the requirements in the Order may result in an enforcement action as authorized by provisions of the California Water Code. If the discharge violates the terms or conditions above, the Central Valley Water Board may take enforcement action, including assessment of administrative civil liability which is a monetary penalty.

Discharge of waste material other than described in the application is prohibited. If the method of waste disposal changes from that described in your application, you must submit a new *Report of Waste Discharge Technical Information* form describing the new operation.

Please note that the Order will expire on 8 October 2014, at which time either (1) a new application with a filing fee will be necessary for regulatory coverage under a subsequently adopted new Order, or (2) the discharge must cease.
