# NOTICE OF APPLICABILITY

## WAIVER OF WASTE DISCHARGE REQUIREMENTS FOR SMALL FOOD PROCESSORS, WINERIES, AND RELATED AGRICULTURAL PROCESSORS WITHIN THE CENTRAL VALLEY REGION

## ORDER R5-2015-0005-0046 HAURY, INC., HAURY FARMS CITRUS PACKING FACILITY, TULARE COUNTY

On 5 February 2015, the Central Valley Regional Water Quality Control Board (Central Valley Water Board) adopted the *Conditional Waiver of Waste Discharge Requirements for Small Food Processors, Wineries, and Related Agricultural Processors within the Central Valley Region, Order R5-2015-0005* (the Waiver).

We are in receipt of your Report of Waste Discharge (RWD) dated 9 July 2015, which stated that you intend to comply with the Tier 2 conditions of the Waiver. Additional information to complete the RWD was submitted on 31 August 2015. Tier 2 allows land application of up to 100,000 gallons of wastewater per year for irrigation of landscaping or crops and land application of residual solids associated with that volume of wastewater. Any process wastewater or residual solids in excess of those amounts must be disposed of off-site at an appropriately permitted facility. If you wish to land apply more wastewater or residual solids, you must submit a new application to obtain coverage under Tier 3 of the Waiver or obtain individual waste discharge requirements prior to increasing the discharge volume.

Based on the information provided in the RWD, we have determined that the discharge meets the required conditions for approval under the Waiver. You are hereby assigned Order R5-2015-0005-0046. A copy of the Waiver is enclosed and also available at:

Please familiarize yourself with the contents of the Waiver, including the Conditions of Discharge (Waiver Attachment A) and Monitoring and Reporting Program (Waiver Attachment B). Discharge must be managed in accordance with the requirements contained in the Conditions of Discharge and with the information submitted in the RWD.

## **DISCHARGE DESCRIPTION**

Haury Farms Citrus Packing Facility (Facility) is on a 60-acre parcel approximately 4 miles north of Visalia in Tulare County.

The Facility consists of an 8,750-square foot cold storage building and a 7,700-square foot packing house adjacent to an actively farmed on-site orchard. On average, the Facility generates about 70,000 gallons of wastewater annually from rinsing and washing of fruit and equipment during the citrus packing season from October through May. Flows are measured by monitoring wastewater storage tank levels before and after discharge. Wastewater is applied by means of a 1,000-gallon water trailer to about 45 acres of adjacent farmland planted in orange trees. Estimated loading rates for nitrogen and biochemical oxygen demand are acceptably low.

On average, the citrus packing operations will generate approximately 250 tons of residual solids annually including culled fruit and stems. Arthur Leyendekker Dairy in Visalia accepts the residual solids for use as animal feed.

## MONITORING AND REPORTING

Attachment B of the Waiver includes specific monitoring and reporting requirements that you must comply with, including routine monitoring and reporting to the Central Valley Water Board. Please review the Monitoring and Reporting Program closely and establish the appropriate record keeping system so that you are able to complete the required Annual Monitoring Report form, which is also contained in Attachment B of the Waiver.

By **February 1 of each year**, the Annual Monitoring Report must be submitted to our office, even if there is no discharge during the reporting year. The 2015 Annual Monitoring Report is due by **1 February 2016**.

### **GENERAL INFORMATION AND REQUIREMENTS**

The Waiver includes specific and general conditions with which you must comply and you must maintain control over the discharge and operate in accordance with the information provided in your RWD and this Notice of Applicability.

Please review this Notice of Applicability carefully to ensure that it completely and accurately reflects the facility name, location, and details of the proposed discharge. Failure to comply with the requirements of the Waiver may result in enforcement action as authorized by provisions of the California Water Code, which could include civil liability. Discharge of wastes not described in the Conditions of Discharge (Attachment A) of the Waiver is prohibited.

Please note that the Waiver will expire on **5 February 2020**, after which you must do one of the following:

- 1. Submit a new RWD with a filing fee (if required) to obtain coverage under a subsequently adopted waiver,
- 2. Submit a RWD with a filing fee to apply for individual or general Waste Discharge Requirements,
