## NOTICE OF APPLICABILITY WAIVER OF WASTE DISCHARGE REQUIREMENTS FOR SMALL FOOD PROCESSORS, WINERIES, AND RELATED AGRICULTURAL PROCESSORS WITHIN THE CENTRAL VALLEY REGION

## ORDER R5-2015-0005-0112 BRYAN D. CLAPPER, LONGCREAUX DISTILLING CO., PLACER COUNTY

On 5 February 2015, the Central Valley Regional Water Quality Control Board (Central Valley Water Board) adopted the *Conditional Waiver of Waste Discharge Requirements for Small Food Processors, Wineries, and Related Agricultural Processors within the Central Valley Region,* Order R5-2015-0005 (Waiver).

We are in receipt of your Notice of Intent (NOI) dated 14 November 2019, and supporting documents. Your NOI states that you intend to comply with the Tier 1 conditions of the Waiver. Longcreaux Distilling Co. (the distillery) is located at 12807 Lone Star Road, Auburn, in Placer County. The distillery is owned by Bryan D. Clapper and operated by Longcreaux Distilling Co., LLC. Tier 1 allows land application of up to 10,000 gallons of wastewater per year for irrigation of landscaping or crops and land application of residual solids (e.g. spent grain, lees) associated with that volume of wastewater. Any process wastewater or residual solids generated in excess of those amounts must be disposed of off-site at an appropriately permitted facility. If you wish to land apply more wastewater or residual solids, you must submit a new application and the applicable fee and obtain coverage under Tier 2 or 3 of the Waiver prior to increasing the discharge volume.

Based on the information provided in the NOI and supporting documents, we have determined that the discharge meets the required conditions for approval under the Waiver. You are hereby assigned Order R5-2015-0005-0112. A copy of the Waiver is enclosed and also available at the <u>State Water Boards Adopted Orders: Waivers webpage</u> (http://www.waterboards.ca.gov/centralvalley/board\_decisions/adopted\_orders/#waivers).

Please familiarize yourself with the contents of the Waiver, including the Conditions of Discharge (Waiver Attachment A) and Monitoring and Reporting Program (Waiver

Attachment B). Distillery waste must be managed and discharged in accordance with the requirements contained in the Conditions of Discharge and with the information submitted in the NOI and supporting documents.

### MONITORING AND REPORTING

Attachment B of the Waiver includes specific monitoring and reporting requirements that you must comply with, including routine monitoring and reporting to the Central Valley Water Board. Please review the Monitoring and Reporting Program closely and establish the appropriate record keeping system so that you are able to complete the required Annual Monitoring Report form, which is also contained in Attachment B of the Waiver.

By **February 1 of each year**, the Annual Monitoring Report must be submitted to our office, even if there is no discharge during the reporting year. The 2019 Annual Monitoring Report is due by **1 February 2020**.

#### **GENERAL INFORMATION AND REQUIREMENTS**

The Waiver includes specific and general conditions with which you must comply and you must maintain control over the discharge and operate in accordance with the information provided in your NOI and this Notice of Applicability.

Please review this Notice of Applicability carefully to ensure that it completely and accurately reflects the facility name, location, and details of the proposed discharge. Failure to comply with the requirements of the Waiver may result in enforcement action as authorized by provisions of the California Water Code, which could include civil liability. Discharge of wastes not described in the Conditions of Discharge (Attachment A) of the Waiver is prohibited.

Please note that the current Waiver will expire on **5 February 2020**. Sometime close to that date you will receive a letter regarding transferal of coverage to the next version of the waiver. Until your discharge is enrolled under a new waiver you are required to comply with the requirements in R5-2015-0005-0112.

#### **DOCUMENT SUBMITTALS**

All monitoring reports and other correspondence should be converted to searchable Portable Document Format (PDF) and submitted electronically. Documents that are less than 50 MB should be emailed to: <u>centralvalleysacramento@waterboards.ca.gov</u>.
