**CEASE AND DESIST ORDER (CDO) RECISSION
(NPDES No. CA0078662)**

for

**EL DORADO IRRIGATION DISTRICT
DEER CREEK WASTEWATER TREATMENT PLANT
EL DORADO COUNTY**

The El Dorado Irrigation District (Discharger) owns and operates the Deer Creek Wastewater Treatment Plant (WWTP) which provides sewerage service to the Cameron Park and Mother Lode Service Area. Existing Waste Discharge Requirements Order No. R5-2002-0210 (existing WDR Order) regulates the discharge of approximately 2.5 million gallons per day (mgd) of treated domestic wastewater is discharged to Deer Creek, a tributary to the Cosumnes River.

The Central Valley Regional Water Quality Control Board (Regional Water Board) adopted Cease and Desist Order (CDO) No. R5-2002-0211, and subsequent amendments, to provide a time schedule for the Discharger to: (1) comply with Receiving Water Limitations and Effluent Limitations for nitrite, nitrate plus nitrite, and total trihalomethanes and specified in the existing WDR Order, and (2) complete and comply with Water Quality Control Plan for the Sacramento and San Joaquin River Basins (Basin Plan) Amendments for pH, turbidity and temperature. The Discharger is in compliance with the requirements of CDO No. 2002-0211, Amendment 1, as amended by Resolution No. R5-2005-0029, and the corresponding compliance dates. The Tentative Regional Water Board Resolution proposes to rescind the existing CDO.

Only designated parties will have the following rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the

evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Regional Water Board no later than **18 January 2007**. The request must explain the basis for status as a designated party and, in particular, how the person is directly affected by the discharge.

Persons wishing to comment on this hearing item must submit testimony, evidence, and/or comments in writing to the Regional Water Board no later than **2 January 2007**. Written evidence or comments submitted after **2 January 2007** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party. All designated parties and interested persons may speak at the Regional Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair
