NOTICE OF PUBLIC HEARING

concerning

**RENEWAL OF WASTE DISCHARGE REQUIREMENTS
AND TENTATIVE TIME SCHEDULE ORDER
(NPDES PERMIT NO. CA0084271)
FOR
MOUNTAIN HOUSE COMMUNITY SERVICES DISTRICT
WASTEWATER TREATMENT PLANT
SAN JOAQUIN COUNTY**

The Mountain House Community Services District (CSD) is the owner and operator of the Mountain House Wastewater Treatment Plant (hereinafter Facility), a publicly owned treatment works located at 17103 W. Bethany Road, Mountain House, California. The Facility provides sewerage services for the community of Mountain House, serving a population of approximately 16,000. The Facility provides tertiary treatment and ultraviolet light disinfection for up to 3.0 million gallons per day (MGD), with plans to expand the capacity to 5.4 MGD to accommodate for planned growth within the service area. Disinfected tertiary treated wastewater from the Facility is discharged to Old River, a water of the United States within the legal boundary of the Sacramento-San Joaquin Delta.

Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5-2013-0004-01 and Time Schedule Order (TSO) R5-2013-0005, issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 31 January 2013. An Order is proposed to renew the NPDES permit. The proposed permit includes new or updated effluent limitations for ammonia, chlorodibromomethane, diazinon and chlorpyrifos, electrical conductivity, and nitrate plus nitrite. The permit removes effluent limitations for dichlorobromomethane because the discharge does not demonstrate reasonable potential to cause or contribute to instream exceedances of the applicable water quality objectives for this constituent. The proposed NPDES permit renewal continues the effluent limitations for temperature that the Facility cannot immediately comply with. A Time Schedule Order is also proposed to extend the time schedule for compliance that was allowed in TSO R5-2013-0005.

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as

a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m. on 20 October 2017**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board, or via email to **RB5S-NPDES-Comments@waterboards.ca.gov** no later than **5:00 p.m. on 20 October 2017**. Written evidence or comments submitted after **5:00 p.m. on 20 October 2017** will not be accepted and will not be incorporated into the administrative record absent a ruling by the Board Chair. Any party requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that accepting the late submission will not prejudice the Central Valley Water Board or any Designated Party. All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Chair.
