The following late revisions have been made to the proposed NPDES Permit for the City of Turlock (Discharger) Regional Water Quality Control Facility to provide clarification and correct typographical errors.

- 1. Page 3. Section II.D. Provisions and Requirements Implementing State Law. This section was missing references to Sections IV.C.4 and VI.C.5.c and has been corrected, as shown below.
 - D. Provisions and Requirements Implementing State Law. The provisions/requirements in subsections IV.B, IV.C, V.B, VI.C.4, VI.C.5.c, and VI.C.6.a are included to implement state law only. These provisions/requirements are not required or authorized under the federal CWA; consequently, violations of these provisions/requirements are not subject to the enforcement remedies that are available for NPDES violations.
- 2. Page E-24. Section IX.C.5. Table E-11 Testing Requirements. This section incorrectly referenced Table E-13. The reference to Table E-13 was corrected to read Table E-11, as shown below.
 - 5. **Table E-11 Testing Requirements.** The Discharger shall comply with the following testing requirements when monitoring for the parameters described in Table E-11.
- 3. Page E-24. Section IX.C.5.a Table E-11 Testing Requirements. This subsection incorrectly referenced Tables E-3 and E-4. The reference to Tables E-3 and E-4 was corrected to reference only Table E-3, as shown below.
 - a. The Discharger is not required to conduct effluent monitoring for constituents that have already been sampled in a given quarter, as required in Tables E-3, except for hardness, pH, and temperature, which shall be conducted concurrently with the effluent sampling.

4. Page E-34. Section X.D.7. Technical Report Submittals. Table E-13.
