The City of Turlock (Discharger) is the owner and operator of the City of Turlock Regional Water Quality Control Facility (Facility), a publicly owned treatment works located at 901 S. Walnut Road, Turlock, California. The Facility provides sewerage services for the City of Turlock and the community services districts of Denair and Keys, serving a population of approximately 91,000. The Facility provides tertiary treatment for an average dry weather flow of 20 MGD. The primary method of disposal for the Facility is discharge of tertiary-treated wastewater to the Delta Mendota Canal via the North Valley Regional Recycled Water Program regulated by Waste Discharge Requirements Order R5-2016-0010 (NPDES No. CA0085316). Tertiary-treated wastewater from the Facility is also discharged, on an as needed basis, to the San Joaquin River, a water of the United States, which is regulated by Waste Discharge Requirements Order R5-2015-0027-01 (NPDES No. CA0078948), issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 17 April 2015 and amended by Order R5-2019-0080 on 5 December 2019.

A tentative Order is proposed to renew Order R5-2015-0027-01 (NPDES No. CA0078948) for discharges to the San Joaquin River. The tentative Order includes new or updated effluent limitations for ammonia, chlorodibromomethane, dichlorobromomethane, electrical conductivity, and nitrate plus nitrite. The proposed permit will remove existing effluent limitations for aluminum, bis (2-ethylhexyl) phthalate, and carbon tetrachloride because the discharge does not demonstrate reasonable potential to cause or contribute to in-stream exceedances of the applicable water quality objectives for these constituents. Furthermore, the tentative Order conditionally authorizes a new seasonal discharge, 1 March to 31 October, of up to 2,033 acre-feet annually to Turlock Irrigation District Upper Lateral 4, a water of the United States.

Written evidence or comments submitted after 5:00 p.m. on 22 December 2020 will not be accepted and will not be incorporated into the administrative record absent a ruling by the Board Chair. Any party requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that accepting the late submission will not prejudice the Central Valley Water Board or any Designated Party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
