Enclosed is a copy of the tentative Waste Discharge Requirements (WDRs) modification for the El Nido Composting Facility. Also enclosed is a Notice of Public Hearing (NOPH) to interested parties, pursuant to §21730 of Title 27, California Code of Regulations, Section 20005 et seq. (Title 27). The enclosed NOPH describes the date, time, and place that the Central Valley Regional Water Quality Control Board (Central Valley Water Board) is scheduled to have a hearing to consider the adoption of the tentative WDRs.

Any comments or recommendations you may have concerning the changing of Prohibition A.2 and Discharge Specifications B.2 in the enclosed tentative WDRs should be submitted to this office in writing by 5:00 p.m. on **19 March 2021** in order that consideration may be given them prior to the meeting of the Central Valley Water Board. Comments on other parts of the tentative Order will not be accepted. Absent a showing of good cause and lack of prejudice to other parties, the Board Chair may exclude comments and evidence received after this deadline.
