Discharger and Tentative Order Information

The City of Turlock is the owner and operator of the City of Turlock, Regional Water Quality Control Facility (RWQCF), a publicly-owned treatment works (POTW) located at 901 S. Walnut Road, Turlock, California. The RWQCF provides sewerage services for the City of Turlock and the community service districts of Denair and Keys, and receives up to 2 million gallons per day (MGD) of primary treated effluent from the City of Ceres. The RWQCF serves a population of approximately 91,000 and is designed to provide tertiary treatment for up to 20 MGD.

The City of Modesto is the owner and operator of the City of Modesto, Water Quality Control Facility (WQCF), a POTW located at 1221 Sutter Avenue, Modesto, California. The WQCF provides sewerage services for the City of Modesto, the community of Empire, and a portion of the City of Ceres, serving a population of approximately 272,000. The City of Modesto is designed to provide tertiary treatment for up to 14.9 MGD.

The Central Valley Regional Water Quality Control Board (Central Valley Water Board) adopted Order R5-2016-0010 (NPDES Permit) on 19 February 2016, authorizing a surface water discharge from the Facilities to the Delta-Mendota Canal, a water of the United States, via the North Valley Regional Recycled Water Program (NVRRWP) Joint Outfall. The NVRRWP Joint Outfall conveys tertiary treated wastewater from the Facilities to the Delta-Mendota Canal, where it is beneficially reused by agricultural users within the Del Puerto Water District via diversions from the Delta-Mendota Canal at locations downstream of the outfall (up to 59,000 acre-feet per year at build out). The NVRRWP also provides recycled water to supplement the irrigation of south of Delta refuges downstream of the Delta-Mendota Canal.

An Order is proposed to renew the NPDES permit. For the City of Turlock RWQCF, the tentative Order removes effluent limitations for bis (2-ethylhexyl) phthalate, aluminum, mercury, and electrical conductivity, the maximum daily effluent limitations for

biochemical oxygen demand (BOD) and total suspended solids (TSS), and the mass-based limits for BOD, TSS, and ammonia from the previous Order. A new chronic toxicity effluent limitation is included in the tentative Order for the City of Turlock RWQCF. For the City of Modesto WQCF, the tentative Order removes effluent limitations for electrical conductivity and mercury, the maximum daily effluent limits for BOD and TSS, and the mass-based effluent limitations for BOD, TSS, and ammonia from the previous Order.

At the hearing, the Central Valley Water Board will hear testimony and oral comments regarding the tentative Order. This proceeding will be a formal adjudicatory proceeding. Pursuant to California Code of Regulations, title 23, section 648.4, the Board Chair may refuse to admit written evidence or comments that are not submitted in accordance with this Notice and shall refuse to do so when there is a showing of prejudice to the Discharger or the Board. Excluded material will not be considered by the Board.

Requesting Party Status

Persons who wish to participate in the hearing as a party must submit a request in writing no later than 5:00 p.m. on **5 May 2022** to the Central Valley Water Board email at RB5S-NPDES-comments@waterboards.ca.gov. The request must include facts demonstrating how the person will be substantially affected by the proceeding.

The Board Chair will not designate a person as a party if the Board Chair determines the designation will impair the interests of justice and the orderly and prompt conduct of the proceeding. The Board Chair, when granting a request for party status, may impose restrictions on the requestor's hearing participation, including limiting or excluding the use of cross-examination and other procedures to promote the orderly and prompt conduct of the proceeding.

Visual Presentations

Hearing participants may use PowerPoint or other visual presentations at the hearing, but the presentation content shall not exceed the scope of previously submitted written material. Presentations, if any, must be provided to the below Central Valley Water Board Contact by 12:00 p.m. on 7 June 2022.

Hearing Procedure and Time Limits

The hearing on the tentative Order will be conducted in the general order listed under California Code of Regulations, title 23, section 648.5, except that the Board Chair may modify the order for good cause.

The **Discharger** and any other designated Party will be advised in advance of the hearing of the total amount of time allocated for their presentation and closing statement. The Discharger and Parties are invited to contact staff in advance of the hearing to discuss how much time they believe is necessary.

Interested persons may speak at the hearing and are expected to orally summarize their written submittals, if any. Each interested person will have 3 minutes to present oral comments. Additional time may be provided, upon request, at the discretion of the Board Chair.

Hearing Accommodations
