## NOTICE OF PUBLIC HEARING concerning

TENTATIVE WASTE DISCHARGE REQUIREMENTS

MODIFYING

SACRAMENTO COUNTY

Waste Discharge Requirements (WDRs) are tentatively being issued to L and D Landfill Limited Partnership and Fruitridge Road Land Company (collectively referred to as "Dischargers") for the L and D Landfill (Facility) in Sacramento (approximately six miles southeast of downtown) in Sacramento County. The Facility is at 8635 Fruitridge Road.

This revised Order prescribes waste discharge requirements (WDRs) which modify 'Attachment G' of the existing WDRs for the Facility, WDRs Order No. R5-2019-0044. The modification would correct 'Attachment G' to reflect the Engineering Alternative final cover systems analyzed and approved by the Regional Board for the Facility. Analysis of the record indicates that the Discharger's proposals, analyses, and Regional Board evaluation of the final cover system for Landfill 1 and Landfill 2 considered a one-foot (1') Foundation Layer and a 40-mil LLDPE geomembrane layer, textured on both sides. The specifications for approved Engineering Alternative final cover systems as described in WDRs Order No. R5-2019-044, Attachment G are inconsistent with the Engineering Alternative final cover systems considered and supported in the record.

These tentative WDRs would also change the existing WDRs Order No. throughout to 'R5-2019-044-001' and modify the paragraph above the signatory line on the Executive Officer's Signature Page. No other amendments are proposed to the existing WDRs.

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m.** on **8 May 2022**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

The Tentative Permit was issued for a 30-day public comment period on **8 April 2022** and comments are due by **5:00 p.m.** on **8 May 2022**. Written evidence or comments submitted after **5:00 p.m.** on **8 May 2022** absent a ruling by the Board Chair. Any person requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that accepting the late submission will not prejudice the Central Valley Water Board or any Designated Party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
