To be given full consideration, any comments or recommendations you may have concerning the tentative WDRs must be submitted in writing to this office by **5:00 p.m. on 9 May 2022**. Absent a showing of good cause and lack of prejudice to other parties, the Board Chair may exclude comments and evidence received after this deadline.

To conserve paper and reduce mailing costs, a paper copy of the tentative WDRs has been sent only to the Discharger. Others are advised that the tentative WDRs will be available, within the next few days, on the Central Valley Water Board's Tentative Orders website under the heading, "Discharger-Specific Order for Future Board Meetings"

This public meeting may take place either in-person or via video and teleconference, and/or any combination of the two. The final meeting agenda will be available on the Board's website at least 10 days before the meeting. The agenda materials may also include staff revisions to the proposed order.

Persons wishing to make non-evidentiary policy statements at the Board meeting (generally limited to 3 minutes) are **not** required to submit written comments, but the Board appreciates receiving such comments in writing by the due date listed above so they may be included in the packages the Board members receive before the meeting.
