NOTICE TENTATIVE WASTE DISCHARGE REQUIREMENTS FOR CALIFIA FARMS, LLC NORTH KERN WATER STORAGE DISTRICT AND PARAMOUNT RANCH COMPANY, LP CALIFIA BAKERSFIELD PROCESSING FACILITY KERN COUNTY

TO ALL CONCERNED PERSONS AND AGENCIES:

Enclosed are tentative Waste Discharge Requirements (WDRs) for Califia Farms, LLC (Califia), North Kern Water Storage District (District), and the Paramount Ranch Company, LP, collectively referred to herein as Dischargers. The tentative WDRs and Monitoring and Reporting Program (MRP) were previously circulated for public review and comment between 8 April and 9 May 2022. In response to comments received during this period, a substantive change was made to the tentative WDRs and MRP – specifically, Paramount Ranch Company, LP has been added as a Discharger. In order to provide interested parties and the public with an opportunity to comment upon the updated tentative WDRs and MRP, both documents are being recirculated for a second

Absent a showing of good cause and lack of prejudice to other parties, the Board Chair may exclude comments and evidence received after this deadline.

To conserve paper and reduce mailing costs, a paper copy of the tentative WDRs has been sent only to the Dischargers. Others are advised that the tentative WDRs will be available, within the next few days, on the Central Valley Water Board's <u>Tentative</u> <u>Orders website</u> under the heading, "Discharger-Specific Items for Future Approval and/or Regional Water Board Meetings"
