### RESPONSE TO COMMENTS REGARDING TENTATIVE RESCISSION OF WASTE DISCHARGE REQUIREMENTS, FOLSOM CORPORATION YARD FORMER LANDFILL, SACRAMENTO COUNTY

The attached document notes the absence of substantive written comments received by the Central Valley Regional Water Quality Control Board from interested persons regarding the tentative Rescission of Waste Discharge Requirements (WDRs) for the closed Folsom Corporation Yard Former Landfill in Sacramento County circulated on 17 February 2023. Written comments were required by public notice to be received by the Central Valley Water Board by 21 March 2023 to receive full consideration.

The Central Valley Water Board staff note the City of Folsom's 21 March 2023 correspondence in general support of the tentative Rescission of WDRs Order. The Central Valley Water Board staff also made minor changes to the tentative Rescission of WDRs to improve clarity and fix typographical errors. A public hearing concerning this matter will be held during the Central Valley Water Board meeting scheduled for 27/28 April 2023 at 8:30 a.m. via video and teleconference, and/or in-person meeting at the Kern County Board of Supervisors' Chambers at 1115 Truxtun Avenue, Bakersfield, California, 93301 pending changes in pandemic restrictions.
