Discharger and Tentative Orders Information

The Aerojet Rocketdyne, Inc. (hereinafter Discharger) is the owner and operator of groundwater extraction and treatment systems ARGET, GET EF, GET HA, GET J, GET KA, GET LA, GET LB, GET AB, WRND GET, Sailor Bar Park GET, and Low Threat Discharges and Cooling Tower 20019. Golden State Water Company (hereinafter Golden State) is the owner and operator of AC-18 Well System and AC-25 Well System. The Discharger operates treatment units at AC-18 and AC-25 Well Systems to treat Golden State's drinking water wells that have been contaminated by the Discharger's past rocket manufacturing and testing operations. ARGET, GET EF, GET HA, GET J, GET KA, GET LA, GET LB, GET AB, WRND GET, Sailor Bar Park GET, Cooling Tower 20019, AC-18, and AC-25, and Low Threat Discharges is hereinafter the "Facility". These treatment systems discharge treated groundwater to surface waters in accordance with an NPDES permit. The maximum daily design flow capacity of the facilities are 5.04 million gallon per day (mgd) for ARGET, 11.52 mgd for GET EF, 3.9 mgd for GET HA, 6.75 mgd for GET J, 5.11 mgd for GET KA, 2.88 mgd for GET LA, 1.44 mgd for GET LB, 1.3 mgd for AC-25, 2.59 mgd for AC-18, 5.76 mgd for GET AB, 2.88 mgd for WRND GET, 0.0008 mgd for Cooling Tower 20019, and 0.58 mgd for Sailor Bar Park GET. The Facility discharges treated groundwater to Alder Creek, American River, Buffalo Creek, Morrison Creek, and Sailor Bar Park Pond, waters of the United States within the American River and Sacramento River watersheds.

Discharges from the Facility are currently regulated by Waste Discharge Requirements

Order R5-2020-0051-003, issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 16 October 2020. An Order is proposed to renew the NPDES permit. A Time Schedule Order is also proposed which includes a compliance schedule for the Discharger to achieve compliance with final N-Nitrosodimethylamine (NDMA) effluent limitations.

At the hearing, the Central Valley Water Board will hear testimony and oral comments regarding the tentative Order. This proceeding will be a formal adjudicatory proceeding. Pursuant to California Code of Regulations, title 23, section 648.4, the Board Chair may refuse to admit written evidence or comments that are not submitted in accordance with this Notice and shall refuse to do so when there is a showing of prejudice to the Discharger or the Board. Excluded material will not be considered by the Board.

Hearing participants may use PowerPoint or other visual presentations at the hearing, but the presentation content shall not exceed the scope of previously submitted written material. Presentations, if any, must be provided to the below Central Valley Water Board Contact by 12:00 p.m. on **14 April 2026**.

Hearing Procedure and Time Limits

The hearing on the tentative Order will be conducted in the general order listed under California Code of Regulations, title 23, section 648.5, except that the Board Chair may modify the order for good cause.

The **Discharger** will be advised in advance of the hearing of the total amount of time allocated for their presentation and closing statement. The Discharger is invited to contact staff in advance of the hearing to discuss how much time they believe is necessary.

Interested persons may speak at the hearing and are expected to orally summarize their written submittals, if any. Each interested person will have 3 minutes to present oral comments. Additional time may be provided, upon request, at the discretion of the Board Chair.
