The Final Agenda will provide the location and format of the meeting, the anticipated date that the proposed order will be considered, and the anticipated order of all agenda items; however, the Board may consider agenda items out of their listed order. ### **Opportunities to Comment**

The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the Order.

The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

**Oral comments** concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain **designated parties** may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The parties subject to the proposed Order are designated parties. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated party. Such requests must be submitted to the Central Valley Water Board no later than 5:00 p.m. on 8 May 2025. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

### **Proposed Order**

If adopted, Waste Discharge Requirements (WDRs) Order R5-2025-XXXX will prescribe additional requirements for management of waste discharged at Foothill Sanitary Landfill, located at 6484 Waverly Road, Linden, CA 95236. Foothill Sanitary Landfill is owned by San Joaquin County Department of Public Works and operated by Foothill Sanitary Landfill (collectively, Discharger). The Discharger will be responsible for maintaining compliance with Order requirements. The Facility is a landfill that has been in operation since 1965 and currently consists of two classified waste management units: LF-1 and LF-2. This amending order adds requirements to the existing Order such as the construction and use of a proposed Class II surface impoundment for leachate management. The Facility's waste discharges are currently regulated under WDRs Order R5-2015-0058. If adopted, the proposed WDRs Order R5-2025-XXXX will update the previous WDRs Order and will result in a long-term leachate management option for the Facility.
