Opportunities to Comment

The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the Order.

The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

Oral comments concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain **designated parties** may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The party's subject to the proposed Order are designated parties. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be

considered a designated party. Such requests must be submitted to Central Valley Water Board no later than 5:00 p.m. on 23 April 2025. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

Proposed Order

If adopted, Order R5-2025-XXXX will authorize a change of ownership of the Franzia Sanger Winery located at 2916 Reed Avenue, Sanger, Ca 93657. The Franzia Sanger Winery was owned and operated and operated by The Wine Group, LLC. The winery is now owned by Cella Mountain, LLC and is operated by The Wine Group, LLC (collectively, Dischargers). The Dischargers will be responsible for maintaining compliance with the requirements of existing WDR Order R5-2014-0094 that regulates the discharge of up to 0.459 mgd and 70 million gallons per year of winery process wastewater to about 203 acres of land application areas.

To conserve paper and reduce mailing costs, a paper copy of the proposed Order was sent only to the Discharger(s).
