NOTICE OF TENTATIVE ORDER AMENDING WASTE DISCHARGE REQUIREMENTS ORDER NO. R5-2019-0024 FOR PRODUCED WASTEWATER REUSE IN KERN COUNTY

TO ALL CONCERNED PERSONS AND AGENCIES:

Enclosed is a tentative Order amending Waste Discharge Requirements Order No. R5-2019-0024 (WDRs) for Sherwood Hills, LLC, Jay LLC, Steir Berton Trust, Homewood Mountain Partners LLC, Famoso Hills Ranch LLC, Yurosek Farms LLC, and E&B Natural Resources Management Corporation (collectively referred to as Discharger hereafter) in Kern County. The tentative Order proposes the following: requires the blending of produced wastewater prior to being reused for irrigation; includes a new daily maximum concentration for boron; and adds a new sampling location. The proposed modifications were made after a revised Report of Waste Discharge was submitted to the Central Valley Water Board by the Discharger.
