Rice production in the Sacramento River Basin (covers Butte, Colusa, Glenn, Placer, Sacramento, Sutter, Tehama, Yolo, and Yuba counties).

Farmlands encompassed by the lower Stanislaus, Tuolumne and Merced River subwatersheds (primary eastside tributaries to the San Joaquin River) and that fall into Stanislaus, Merced, Madera, Calaveras, Mariposa and Tuolumne counties.

Grassland Drainage Area Steering Committee

Located west of the San Joaquin River in the Grassland Watershed, between Los Banos and Mendota in Fresno County.

Irrigated Lands within the Sacramento River Basin (including all or portions of Amador, Butte, Colusa, El Dorado, Glenn, Lassen, Modoc, Lake, Napa, Nevada, Placer, Sacramento, Shasta, Siskiyou, Solano, Sutter, Tehama, Yolo, and Yuba counties).
