NOTICE OF PUBLIC HEARING concerning Proposed Amendments to the Water Quality Control Plan for the Lahontan Region for Replacing the Pesticide Water Quality Objective with a Regionwide Waste Discharge Prohibition with Exemption Criteria

NOTICE IS HEREBY GIVEN that the California Regional Water Quality Control Board, Lahontan Region (Water Board) will hold two public hearings as part of the process for considering amendments to the Water Quality Control Plan for the Lahontan Region (Basin Plan) which include removing the pesticide water quality objective and replacing it with a regionwide prohibition on pesticide discharges and criteria for providing exemptions to the prohibition. The Basin Plan amendment process is authorized under California Water Code section 13240. The Basin Plan amendment is a project subject to the California Environmental Quality Act (CEQA) and the Water Board is the lead agency. The Water Board wishes to obtain public input on the proposed Basin Plan amendment.

In compliance with California Code of Regulations, title 23, section 3720 et seq., the Water Board has prepared a draft Basin Plan amendment which includes a draft supplemental environmental documentation (SED), an environmental checklist, and the proposed Basin Plan language. The draft SED was prepared pursuant to Public Resources Code section 21080.5. These documents will be accessible at the Water Board offices in South Lake Tahoe and Victorville or on the web page at http://www.waterboards.ca.gov/lahontan/water_issues/programs/basin_plan/index.shtml. The public review and comment period will close on May 13 at 5 p.m. and will start a minimum of 45 days prior.
