### NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT ON

### PROPOSED ALTERNATIVE METHOD TO DEMONSTRATE COMPLIANCE WITH TIME SCHEDULE ORDER R8-2019-0050, AS AMENDED BY R8-2023-0063 AND R8- 2025-0003, TO COMPLY WITH FECAL COLIFORM WASTE LOAD ALLOCATIONS FOR NEWPORT BAY

**NOTICE IS HEREBY GIVEN** that the Santa Ana Regional Water Quality Control Board (Santa Ana Water Board) is accepting public comments on a proposed alternative method to demonstrate compliance with R8-2019-0050 (the Proposal). Staff of the Santa Ana Water Board received the Proposal from the County of Orange via a letter dated June 16, 2025. The Proposal was submitted in accordance with Provision 23 of Time Schedule Order R8-2019-0050, as amended (the TSO), to comply with fecal coliform waste load allocation for Newport Bay.

### ABOUT THE PROPOSAL

The requirements for the Proposal come from Provision 23 of the TSO. Provision 23, allows, but does not require, permittees to propose an alternative method for determining compliance with the TSO. Provision 23 requires any proposal for an alternative method must:

- Include sufficient justification for its use.
- Be approved by the Executive Officer of the Santa Ana Water Board.
- Undergo 30 days of public review.

The full requirements for the Proposal are detailed in Provision 23 of the TSO, which is available upon request.

## SUBMISSION OF WRITTEN COMMENTS

The Santa Ana Water Board will accept written comments on the Proposal during a 30-day public comment period that begins on June 25, 2025, and ends on July 24, 2025. Comments must be received no later than 5:00 pm on July 24, 2025.
