

## Santa Ana Regional Water Quality Control Board

### 2021 Scrap Metal Qualified SWPPP Developer/Practitioner Exams and Certified Persons Training Schedule (English and Spanish)

The Scrap Metal Storm Water General Permit, Order No. R8-2018-0069, requires persons who develop or implement a facility's Storm Water Pollution Prevention Plan (SWPPP) and whom prepares a Corrective Action Plan (CAP) to have Regional Board certification.

The Scrap Metal Qualified SWPPP Developer (SM-QSD) and Scrap Metal Qualified SWPPP Practitioner (SM-QSP) certification exams will be held on June 11, 2021, September 30, 2021, and December 16, 2021.

Due to COVID-19 precautions, the exam will be held remotely until further notice. A valid email address is required. The exam check-in begins at 9:30 am and the exam period ends at 12 noon.
