Staff has reviewed the project proposal for removal and replacement of existing rip rap on the shoreline of 501 First Street (First Street and I Avenue in Coronado). The proposed project includes the removal (approximately 450 cubic yards) and replacement (approximately 404 cubic yards) of existing rip rap in compliance with rip rap Installed at 401 First Street. Filter fabric and quarry rock rip rap will be placed between approximately +1 and +4 feet Mean Lower Low Water along approximately 80 feet of shoreline. Surface area will total approximately 480 square feet. No vegetation exists in the project area. All work will be done from shore when the area is dry.

-Based upon the above description, the project is Categorically Exempt pursuant to California Environmental Quality Act Guidelines Section 15302 (Class 2), and Resolution 97-191:

## Replacement or Reconstruction

- b. Replacement or Reconstruction: Includes replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site and will have substantially the same purpose and capacity as the structure being replaced. This exemption includes, but is not limited to:
  - (1) Replacement or reconstruction of mooring facilities, piles, floats, piers, wharves, marine ways, bulkhead, revetment, buoys, or similar structures where the new structure will be on essentially the same site as the structure replaced and will have substantially the same size, purpose and capacity as the structure replaced.

## Project Description:

The project site is located on the shoreline of 501 First Street (First Street and I Avenue in Coronado). The proposed project includes the removal (approximately 450 cubic yards) and replacement (approximately 404 cubic yards) of existing rip rap in compliance with rip rap installed at 401 First Street. ## Port Master Plan Reference:
