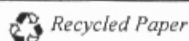
Enclosed are copies of Tentative Resolution No. R9-2008-0069 and Tentative Order No. R9-2008-0071 that will be presented to the Regional Board for adoption at their scheduled meeting on June 25, 2008. Copies of the enclosed documents can also be obtained from our website at: <http://www.waterboards.ca.gov/sandiego/>.

If adopted, the Resolution will certify the Negative Declaration of the environmental impacts from the discharge of calcium peroxide and sodium persulfate (oxidants) into groundwater to cleanup petroleum hydrocarbons, volatile organic compounds (VOCs), and fuel oxygenates that have been detected in the vicinity of 2 service stations at 105 and 112 Rancho Santa Fe Road in San Marcos, San Diego County. The Tentative Order will prescribe Waste Discharge Requirements for the discharge of these oxidants into groundwater. Both the Resolution and Tentative Order will be presented to the Regional Board at their scheduled meeting on Wednesday, June 25, 2007. The meeting will begin promptly at 9:00 AM and will be held at the following location:


