SUBJECT: TENTATIVE ORDER NO. R9-2009-0094; NPDES PERMIT NO. CAG679001; GENERAL WASTE DISCHARGE REQUIREMENTS FOR DISCHARGES OF HYDROSTATIC TEST WATER AND POTABLE WATER TO SURFACE WATERS AND STORM DRAINS OR OTHER CONVEYANCE SYSTEMS WITHIN THE SAN DIEGO REGION

Enclosed is a copy of Tentative Order No. R9-2009-0094, NPDES Permit No. CAG679001, including a monitoring and reporting program and fact sheet which Regional Board staff intends to present to the Regional Board for adoption at their regularly scheduled meeting on August 12, 2009.

If adopted, tentative Order No. R9-2009-0094, NPDES Permit No. CAG679001, would update waste discharge requirements for the discharge of waste associated with hydrostatic test water and potable water to surface waters within the San Diego Region. If adopted, Order No. R9-2008-0082 would supersede Order No. R9-2002-0020, except for enforcement purposes.


fully study and consider written material, written comments should be received in the Regional Board's office no later than 5:00 p.m. on Wednesday, August 5, 2009.
