The purpose of this e-mail is to request that you delay the adoption hearing on subject permit, and schedule a formal workshop early next year to discuss the revised tentative permit and the changes that staff has made. The 2002 permit can be continued until the new permit is adopted. I was surprised when we received the lyris e-mail on November 22nd for the December 16th Board meeting that showed this item on the non-consent calendar, since we hadn't received a revised version of the permit and hadn't heard anything since September. In fact, we didn't receive a revised permit until late Thanksgiving eve, and then a subsequent version last Thursday, December 3rd. Although a response to comments is referenced, I don't recall seeing a copy.

We sent a comments letter on the first iteration of the permit back in July, and understood that staff was meeting with the TAC and revising the permit based on input received. Our review of the latest version of the permit indicates that there are many changes and new provisions that warrant a dialogue with stakeholders in a workshop format before this goes forward for an adoption hearing.

We will be sending a letter that outlines the issues of concern, and formally requests that this item be delayed and a workshop be scheduled.

Thank you in advance for your consideration. We look forward to working with you and your staff to obtain a viable permit for all of the stakeholders.
