Everett, (pls share this email with Gabe...I can't find her email address)
Catherine sent out this morning a Hearing Procedure for our Escondido case that sets forth deadlines for submission of evidence and argument for the February 2009 Bd proceeding. More significantly, it requires submission of requests for Delegated Party status by December 5. Depending on how things go between now and the hearing as to agreement on the SEP, you may want to apply for status. As far as I know, the most critical step that remains so that we can present this as a jointly-supported settlement is for you, Gabe and the City to respond to Rebecca's issues regarding the SEP proposal. I hope that is completed or close to complete. Once that is done we can move on to finalize the settlement agreement and draft a proposed order that includes the SEP. If this doesn't get done, we'll have to proceed on February 11 with (a) the stipulation or (b) a hearing that would allow the Board to impose their own penalty amount. Thanks for your attention to this matter.
