Issuance of Administrative Civil Liability Order. On November 18, 2009 the California Regional Water Quality Control Board, San Diego Region (Regional Board), will consider issuing an order imposing administrative civil liability as recommended in Complaint R9-2009-0042 against the City of San Diego for \$620,278 in penalties for alleged violations of Order No. R9-2006-0003-DWQ, Statewide General Waste Discharge Requirements for Sanitary Sewer Systems, from the discharge of 381,185 gallons of untreated sewage to Lake Hodges during August 20-24, 2007.

The Regional Board will consider whether to approve, modify, or reject the proposed assessment. The Regional Board may consider directing a portion of the liability to supplemental environmental projects. A public hearing will be held unless the discharger waives its rights to a hearing. Written comments regarding the allegations contained in Complaint No. R9-2009-0042 will be accepted through November 5, 2009.

The Regional Board's November 18, 2009 meeting will be at the Regional Board office located at 9174 Sky Park Court, San Diego, California. The meeting will begin at 9:00 a.m. Oral comments for this item may be made during the meeting upon receipt of a request to speak slip.
