SUBJECT:	Rescission of Waste Discharge Requirements: U.S. Navy Public Works, NASNI Bioremediation Facility; Rainbow Municipal Water District, Plant B; and John Konyn and Son Dairy (Tentative Order No. R9-2009-0098) <i>(Cathryn</i> <i>Henning)</i>
PURPOSE:	To adopt tentative Order No. R9-2009-0098 rescinding Waste Discharge Requirements (WDRs) for Order Nos. R9- 2002-0040, 93-001, and 95-013.
PUBLIC NOTICE:	All interested parties were notified via email of the action to rescind Order No. R9-2002-0040 on July 23, 2009. In addition, the action to rescind Order No. R9-2002-0040 was published in the San Diego Union Tribune on July 26, 2009. All interested parties were notified orally of the action to rescind Order Nos. 93-001 and 95-013 on August 6, 2009. These public notification actions satisfy the requirements of California Water Code section 13167.5.
DISCUSSION:	Tentative Order No. R9-2009-0098 (Supporting Document No. 1) will rescind Order No. R9-2002-0040, <i>Waste</i> <i>Discharge Requirements for the Department of the Navy</i> <i>Class II Waste Management Facility, Naval Air Station North</i> <i>Island, San Diego County;</i> Order No. 93-001, <i>Waste</i> <i>Discharge Requirements for Rainbow Municipal Water</i> <i>District, Plant B; San Diego County;</i> and Order No. 95-013 <i>Waste Discharge Requirements for John Konyn, John Konyn</i> <i>and Son Dairy, San Diego County.</i>
	On August 5, 2008, Naval Facilities Engineering Command Southwest on behalf of the Department of Navy submitted a closure report for the Class II Waste Management Facility at the Naval Air Station North Island in San Diego, California. Based on the information contained in the information report (Supporting Document No. 2), the Department of Navy has complied with the applicable clean closure requirements in CCR Title 27 section 21090(f).

	On August 6, 2009, Rainbow Municipal Water District (RMWD) requested rescission of Order No. 93-001. RMWD ceased operating its wastewater treatment plant in 1988 upon completion of a connection to the City of Oceanside's sewage collection system. Subsequent inspections by Regional Board staff confirmed that the treatment plant is inoperable, and that wastewater from RMWD's sewage collection system is being sent via a pipeline to the City of Oceanside's San Luis Rey Wastewater Treatment Plant. On August 6, 2009, a representative of John Konyn and Son Dairy requested rescission of Order No. 95-013. An inspection on that date verified that the dairy operation and
	discharge to the wastewater pond has been terminated. The closing of the dairy was the subject of an article in the North County Times on January 12, 2009 (Supporting Document No. 3)
